THE MUSEUM WAS OPEN BY APPOINTMENT ONLY IN FEBRUARY 2021, AFTER BEING CLOSED THROUGH JANUARY DUE TO GOVERNOR TIM WALZ'S PANDEMIC GUIDELINES FOR NON-ESSENTIAL BUSINESSES. DURING THAT TIME, EXECUTIVE DIRECTOR MARY WARNER RE-WROTE THE MUSEUM'S ARTICLES AND BYLAWS TO FIT CURRENT NEEDS OF THE ORGANIZATION.
